Persons that are not exposed to individual areas of hazard are not generally required by iOSHA to do regular training on those topics.  
 This may not be a complete list for your organization depending on the operations that your employees are exposed to.  
 Schools/Colleges - Have a broad range of what employees are exposed to. Custodians would be exposed to many areas for example.  
 \*"Annual" training may be required for individuals exposed to those work areas but not for all employees depending on activities  
 \*New employees should complete safety training for all areas shown that they are exposed to.  
 Cyber Security Training as of 5-30-23 - 20 ILCS 1375 requires Phishing, Spyware prevention, ID Theft and breach awareness.
